






# What is your role in your organization?

- I recommended the establishment of a "New ideas generation and implementation committee" to identify ways to make ECCE more successful and effective.
- Conferences (apart from the General Assembly) to be organised to disseminate information/results of the working groups and committees; and encourage other members to present related research on the subject.

Moderated and highly professional discussions (public or limited to members only) could expose the active existing members and attract the new ones.

MD RSCE has an Engineering Council the tasks of which are the implementation, standardization and legal support of new technologies and materials in construction. It is directly connected with ecology, time schedules and costs of construction. The difficulty occurs due to the complexity of the bureaucracy. The problem is more complex

In order to improve the impact of ECCE's initiatives and deliverables, ECCE shall report these initiatives to the authorized institutions and organizations of the member countries in an official letter. It is necessary to inform the public about these studies.

National workshops to inform the research process of the papers, and subsequently national conferences where these papers are presented.

Experts from the specific nation should be asked for any comment.

Publishing the previous and the current position papers on the open-access website together with constantly updated feedback (if any) and progress of the topics addressed by relevant position papers.

Possibly provide an accompanying email which we could use to disseminate the papers to relevant groups - this would explain in a few sentences the purpose of the paper and its results.

The target group should be clear.





Value THE PERFORMANCE of the Position Paper works in different aspects (1 poor - 5 excellent)



The process of finalizing it is rather long, the papers too. The Position Papers have to be directly addressed to ... and the content, of course, too. Precise, short and understandable for everybody.

Few feedback from the real decision makers (both national and EU)

I can only find position papers from 2020 on the ECCE website, but the ones I have read are of good quality. It would be good to work out how to better disseminate these to ICE members.

ECCE should prepare an instruction on the code of conduct of "Ethics and Conduct of Professional Engineers" which indicates that; All decisions and actions of engineers have a large impact on the environment and on society. The engineering profession thus has an obligation to ensure that it works in the public interest and with regard for health, safety and sustainability. Individual engineers have a personal obligation to act with integrity, in the public interest, and to exercise all reasonable skill and care in carrying out their work.

ECCE also prepare a circular letter to all National Governments which indicates that; Education is the way to innovation so there must be a new "Education Policy" to ensure that young people will obtain a solid education in the natural sciences and engagement with technology, nature, physics, mathematics and chemistry in primary and secondary school, to lay the foundation for a lifelong interest



Do you consider ECCE costs (fee + attendance) would be considered as "value for money"?





Do you think that the creation of an ECCE Strategic Plan will be useful?






